Safety Rules For The Swimming Facilities

The swimming facilities at Association Island RV Resort & Marina consist of an outdoor swimming pool and a man-made sand beach. Please note: **NEITHER OF THESE TWO SWIMMING FACILITIES IS SUPERVISED BY A LIFEGUARD OR OTHER RESPONSIBLE PERSON.** In place of on-site supervision, these facilities have established a series of safeguards to be followed by all resort guests.

SAFETY RULES

Safety is a joint responsibility! Please read the safety rules outlined below. We are required to notify you of these rules, to insure that water rescue equipment is at the poolside and beach, and to maintain these areas in a sanitary manner. If you notice any problem with the water quality or the absence of water rescue equipment, please notify the resort office. **Your safety is important to us.**

- The pool and designated beach area are the **ONLY** places where swimming or wading is allowed. Swimming and wading are not permitted from RV sites.
- **NEVER SWIM ALONE.** A minimum of two adults, 18 years of age or older, must be present at a swimming facility whenever one is in use. One adult must be out of the water and ready to respond to any emergency situations. At least one adult must be present on the pool deck or beachfront.
- **THERE IS NO SUBSTITUTE FOR ADEQUATE SUPERVISION.** Children under the age of 16 must be accompanied by a parent or guardian.
- **IN CASE OF EMERGENCY, NOTIFY THE RESORT OFFICE AND/OR CONTACT HELP BY DIALING 911 AS SOON AS POSSIBLE.** A telephone is available at the back of the Bathhouse or at the Resort Office.
- Only use these swimming facilities during posted hours of operation.
- Don't drink and swim.
- Jumping and diving are prohibited at the swimming facilities. Running is prohibited at the pool.
- Glass bottles and containers as well as pets are prohibited at the swimming facilities.
- Only registered resort patrons who have signed the "Rules & Safety Acknowledgement" (for and on behalf of all members of their party) may use the swimming facilities.

RESORT POLICIES & RULES

For everyone's mutual enjoyment, the resort has policies & rules in place for the consideration of all our guests and for the protection of the property and environment. While some of the policies may seem onerous in isolation, our policies overall are designed for the comfort and better enjoyment of all of our guests in aggregate. Failure to abide by our policies may result in eviction without refunds. To avoid any unpleasanties (we don't enjoy rules enforcement any more than you do), please take a moment to review our key rules listed below, and be sure to review and obey all the rules when you arrive.

1. Resort patrons are responsible for the safety & conduct of all members of their party and for informing their entire party of Resort rules.
2. Gate access: a 24-hour gate access card is available with a refundable \$10 cash deposit. The gate is manned from 8:30 am to 8:30 pm. Registered guests without access cards who seek re-entry after 8:30 pm must park overnight by the office & walk to your site. Parking passes must be displayed when on premises.
3. Upon arrival and during registration, please park in the entrance circle before reaching the Island House to allow other customer traffic to pass; do not park block the security gate.
4. Visitors must register, pay guest fees and park in Guest Parking. Day visitors must leave by 9 pm, or register as overnight visitors by 8 pm. Fees for unregistered visitors & vehicles will be charged to the guest registered for the site/slip/cottage.
5. For cottage customers: a \$200 cash security deposit is required, which is refundable upon satisfactory inspection at check-out. Pets & smoking not allowed in cottages.
6. Parking: 1 passenger vehicle & 1 RV per site. Extra vehicles, boats & boat trailers must be parked in Guest Parking. No parking on the grass.
7. Max # of occupants per rv site or boat slip is 8. Max per cottage is 6.
8. Quiet hours are 10 pm - 7 am Sun - Thurs, and 11 pm - 7 am on Fri - Sat.
9. **The Speed Limit from the bridge to the end of the causeway is 15 mph. The Speed Limit at the start of Association Island and within the security gate is 5 mph. Safety of our guests is of utmost importance; speeding violations will not be tolerated.**
10. Per NYS regulations: sewer hookups require elbow & sewer gasket to prevent spills, no formaldehyde based & no colored tank additives, no hazardous waste disposal, no vehicle washing. \$50 fine for violations.
11. Guests must take garbage in tied bags to dumpsters. Disposal of hazardous waste is not permitted on the premises. \$50 fine for violations.
12. No moving of fire-rings or picnic tables. \$50 fine for violations.
13. Camping tents are not allowed. Screen tents permitted for dining (no sleeping) with prior notice to office staff. \$50 fine for violations, and tents must be removed immediately.
14. Entry to unrenovated buildings is strictly prohibited.
15. No swimming or wading from RV sites. There are designated areas for swimming: at the pool & at the swimming beach.
16. Absolutely no firearms, fireworks, or other incendiary devices.
17. Swimming rules: never swim alone, there must be at least 2 adults present at the pool or beach before entering the water. Children under 16 years must be accompanied by an adult.
18. Bicycles & scooters: children must wear safety helmets. Not allowed after sunset. Only electric & 4-cycle gas scooters allowed.
19. Dock usage and access only permitted for registered marina customers.
20. Fishing not permitted from docks, from bridge, or from lakefront rv sites. There are designated areas for fishing on the property or charter fishing available. Great fishing for bass, lake trout, perch, bullhead, walleye & salmonids. Fishing licenses required if > 16 yrs; can obtain from NYS DEC online 3 wks prior to arrival.
21. Pets: well-behaved dogs & cats are welcome, max 2. Sorry but perceived aggressive breeds are not welcome. Proof of rabies vaccination required. Pets not allowed in cottages, buildings, pool area, beach & recreation areas. Pets must be on physical leash no more than 6' in length, must not be left unattended, must be picked up after. If in doubt, please leave pet at home or in a boarding kennel.
22. Do not feed the wildlife, especially the ducks & geese. Wildlife is unpredictable & can be aggressive.
23. For smokers: please dispose of cigarette butts properly (not on the ground). No smoking in any building.
24. Resort is not responsible for your personal belongings. Use at your own risk.
25. At all times, be courteous to your fellow guests (do not walk thru other rv sites, play music softly, etc). If a fellow guest or pet is being disruptive, please notify office and provide location.
26. Please be respectful of the environment.
27. If you need an exception to our policies, please get specific approval from a manager.
